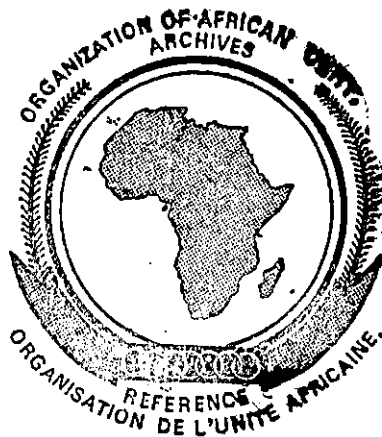

PROPOSED PLAN TO ESTABLISH A SUB-REGIONAL OFFICE OF THE CO-ORDINATING COMMITTEE ON THE LIBERATION OF AFRICA IN LUSAKA

During its 14th Regular Session, the Co-ordinating Committee for the Liberation of Africa decided to set up a sub-office in one of the neighbouring Member States. Consequent upon this decision, the Permanent Representatives of the Liberation Committee at its meeting in Dar-es-Salaam on March 20th 1969, agreed that the sub-office to be established in Lusaka, the Republic of Zambia should, among other things, carry out the following functions:-

- a) management of the Contingency Fund for Emergency purposes;
- b) payment to liberation movements of a maximum limited amount of money by the officer-in-charge on his own authority;
- c) supervision of all assistance given by the Liberation Committee to different movements and general supervision on some of the activities of these movements;

During the Thirteenth Session, the subject of establishing a sub-office of the Liberation Committee in Lusaka was discussed once again in Committee A. The Committee studied document CM/172 relating to the proposed plan and, after making observations, AGREED to the plan in principle and DECIDED to refer the matter to the Advisory Committee on Financial and Budgetary Matters to determine the financial implications (Document CM/Cttee A/Draft Rpt (XIII) refers.

In pursuant of the above decision, therefore, the General Secretariat is attaching hereto draft estimates for consideration by the Ninth Session of the Advisory Committee for inclusion in the 1960/1971 Budget. In this respect, it is mentioned that the appropriations in the budget are based upon current comparative Government salary levels obtaining in Zambia and are intended to attract and retain the services of the most suitable candidates for the posts listed therein. The General Secretariat is of the opinion that, if approached, the Government of the Republic of Zambia, which is already doing much in this respect would more than likely find its way in providing any assistance that might enable this office to be

established within reasonable costs. If this were possible, the cost of U.S.\$38,482.00 estimated for establishing this office would be reduced tremendously. The need to establish a reliable sub-office for this difficult task cannot be over-emphasized; indeed, it is imperative that only the best of staff must be employed.

Needless to say, the General Secretariat would like to request the Advisory Committee to give this matter careful consideration and treat it as urgent in view of the critical turn that events have taken in that Southern part of our Continent.

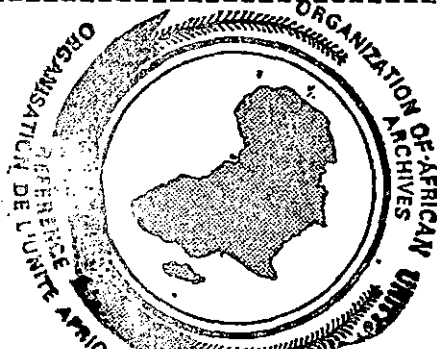
